

We are pleased to inform you that Central Warehousing Corporation, a Schedule-A, Mini Ratna, Category-I, Central Public Sector Undertaking under the administrative control of Ministry of Consumer Affairs, Food and Public Distribution, providing scientific storage facilities for agricultural inputs, produce and other notified commodities besides providing logistics infrastructure like CFSs/ICDs, Land Custom Stations, Air Cargo Complexes etc. for import-export cargo, requires the services of Two (02) officers from Indian Railways of Traffic Service cadre (IRTS) working in the pay scale of Rs.12000-375-16500 (Pre-revised 15600-39100) with Grade Pay 7600)(Revised to CDA pay Matrix Level 12 of 7<sup>th</sup> CPC at Rs.78800 with 4 years' relevant experience in the mentioned pay scale or CDA matrix level 13 with relevant experience for managing Rail based operations of the Corporation.

In this regard, Department of Public Enterprises vide letter F.No.23 (6)/06-GM-FTS-4571 dated 12.10.2023 has communicated the approval of competent authority for exemption of 03 posts of General Manager (General) at E-7 in CWC from the rule of immediate absorption for a period of three years from the date of filling up the posts (copy enclosed), through the administrative Ministry i.e. Ministry of Consumer Affairs, Food and Public Distribution.

The incumbent will be inducted on deputation basis as General Manager (General) in the pay scale of Rs. 1,00,000-2,60,000(IDA)(E-7) and the salary/perks/entitlement of deputationists shall be governed strictly as per extant DPE guidelines.
